## RELEASE, LIABILITY, WAIVER, INDEMNIFICATION AND ASSUMPTION OF RISK ("Release")

### Motorcycle Racing Could Cause Serious Injury

#### Section 1

In consideration of being considered to participate in the Buell Motorcycle Company Contingency Program (the "Program"). I, the undersigned, for myself, successors, heirs and assigns, release, waive liability, promise never to sue, and forever discharge Buell Motorcycle Company and its affiliated companies (collectively "Buell") and each of their subsidiaries, agents, employees, dealers, servants, officers, directors and shareholders (collectively with Buell, "Released Parties") from all claims, including but not limited to claims for negligent acts or omissions, actions or judgments I may have or claim to have against Released Parties, or any of them, for ALL PERSONAL INJURIES, INCLUDING DEATH AND INJURIES TO PROPERTY, real or personal, caused by or arising out of my participation in the Program.

**I understand that motorcycle riding is inherently dangerous.** I represent to Buell that I have had sufficient experience riding motorcycles to understand all the risks involved in motorcycle racing. **I expressly and voluntarily assume all risk of personal injury or death sustained while participating in the Program, whether or not cause by the negligence or other fault of Released Parties, or any of them,** including but not limited to EQUIPMENT MALFUNCTION FROM WHATEVER CAUSE, INADEQUATE TRAINING OR SUPERVISION, DEFECTIVE DESIGN OF EQUIPMENT OR MOTORCYCLE RACE COURSE, FAILURE TO KEEP SAFE, FAILURE TO INVESTIGATE OR SUPERVISE OTHER RIDERS, OR FAILURE TO WARN OF POTENTIAL RISKS.

I further agree, for myself, successors, heirs and assigns, to indemnify, defend and hold all of the Released Parties harmless from all claims and suits for personal injuries, including death and damage to property caused by any act or omission arising out of my participation in the Program, and from all judgments recovered and from all expenses incurred in defending said claims or suits. I further agree that any photographs, pictures, slides and/or movies taken of me by Buell or any third party on behalf of Buell in connection with my participation in the Program, or any reproduction of same as well as my name may in any manner be used by Buell and its affiliated Companies or by any person, corporation or association, authorized by Buell and its affiliated Companies for any reason in any media.

I am in good health and have no physical condition that would prevent me from participating in this Program.

I further agree to waive all benefits flowing from any California statute or the statute of any other state which would otherwise limit the scope of this release including, but not limited to, Section 1542 of the California Civil Code which provides:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing the release which, if known to him, must have materially affected his settlement with the debtor."
